Mark Martinez moved that the Board adopt the Resolution (in the form provided to the Board) authorizing the Superintendent to publish notice of the District's intent to sell the surface only of four Tracts of District Real Property, commonly known as the Novice School Property, and described in the Resolution, pursuant to Texas Local Government Code Section 272.001, to receive and publically open bids and to present the bids to the Board of Trustees for final action, and that a copy of such resolution be attached to the official minutes of this meeting. Jody Payne seconded the motion and it passed unanimously.

Jody Payne made a motion to approve the purchase of 85 band uniforms in the amount of \$43,171.50. Rowdy Allen seconded the motion and it passed unanimously.

The Board went into Closed Session at 6:50 p.m. under Texas Government Code Section 551.074 to discuss personnel. The Board came out of Closed Session and back into Regular Session at 7:15 p.m. with no action taken.

John Casey made a motion to hire Karen Huff, Business Manager, and Paul Martin, Technology Director, on a 12-month contract for the 2014-2015 school year. Rowdy Allen seconded the motion and it passed unanimously.

Mark Martinez made a motion to hire Lorrie Payne, Curriculum Director, on a 12-month contract for the 2014-2015 school year. Rowdy Allen seconded the motion. Voting for the motion were Sue Sloan, Rowdy Allen, John Casey, and Mark Martinez. Jody Payne abstained. Motion passed.
