Joshua Hale seconded the motion. Motion passed 5-0.

Personnel – Consider Contract Extensions:

Joshua Hale made a motion to extend 11-month contracts one year to Diana Dobbins, High School Principal; Thomas King, Jr. High Principal; and John Elder, Athletic Director. John Casey seconded the motion. Motion passed 5-0.

Personnel – Consider Contract Renewals: John Casey made a motion to hire Kristi Greaves, Business Manager; Paul Martin, Technology Director; and Bobby Cox, Director of Maintenance & Operations, on a 12-month term contract for the 2021-2022 school year. Becky Dobbins seconded the motion. Motion passed 5-0.

Personnel – Consider Accepting Resignations from Personnel:

Becky Dobbins made a motion to accept the resignation from Thea Griffin effective the end of the 2020-2021 school year as recommended

by the administration. Lee Morrison seconded the motion. Motion passed 5-0.

Consider Approving Purchase of 71 Passenger Bus:

A motion was made by Becky Dobbins to accept the bid from Longhorn Bus Sales for a 2022 Integrated CE S 78 Passenger Bus in the amount of \$101,106.00 as recommended by the administration. Lee Morrison seconded the motion. Motion passed 5-0.

Consider Approving Sale of House Located at 718 West 7th St., Coleman, TX:

No bids were received for the removal of the house located at 718 W. 7th Street, Coleman, TX. Mr. McDowell explained he was working on several options to have the house removed from the property. Joshua Hale made a motion to approve the disposal of the building as Mr. McDowell deems to be in the best interest for the district. Becky Dobbins seconded the motion. Motion passed 5-0.
