Mark Martinez made a motion to certify candidates are unopposed for election to office for the election scheduled on May 10, 2014. Rowdy Allen seconded the motion and it passed

unanimously.

Mike Barker made a motion to declare the May 10, 2014 CISD School Trustee Election to be canceled. Rowdy Allen seconded the motion and it passed unanimously.

Don McKee, CPA representing Reed, McKee & Co., presented the Novice ISD Financial Report for the six months ending on February 28, 2013. Mike Barker made a motion to accept the Novice ISD Financial Report as presented by Reed, McKee and Co., P.C. Rowdy Allen seconded the motion and it passed unanimously.

**Closed Session:** 

The Board went into Closed Session at 5:45 p.m. under Texas Government Code Section 551.074 to discuss personnel. The Board came out of Closed Session and back into Regular Session at 6:18 p.m. with no action taken.

Personnel – Consider Recommendation to Hire Personnel for the 2014-2015 School Year:

Jody Payne made a motion to hire the high school personnel for the 2014-2015 school year as recommended by the administration. Rowdy Allen seconded the motion and it passed unanimously.

Mark Martinez made a motion to hire the junior high school personnel for the 2014-2015 school year as recommended by the administration. John Casey seconded the motion. Voting for the motion were Sue Sloan, John Casey, Mark Martinez, Rowdy Allen, Mike Barker and Jody Payne. Billy Bledsoe abstained. Motion passed.

Jody Payne made a motion to hire Nadir Dalleh for the 2014-2015 school year. Mike Barker seconded the motion and it passed unanimously.

Consider Approving the 2014-2015 School Calendar:

Mark Martinez made a motion to approve the 2014-2015 school calendar as presented with the first day of school being August 25, 2014 and the last day of school being May 28, 2015. Jody Payne seconded the motion and it passed unanimously.

Consider Approving State Waiver for Staff Development and Early Release Days for 2014-2015:

A motion was made by Jody Payne to approve the State Waiver for 3 Staff Development-General Days, 2 Staff Development-Subject Area days, and 6 early release days for the 2014-2015 school year. Rowdy Allen seconded the motion and it passed unanimously.
