Mark Martinez made a motion to approve the minutes of the 5:31 p.m. Special Meeting of July 24, 2012. The second was made by John Casey. Voting for the motion were Sue Sloan, Jody Payne, John Casey and Mark Martinez. Billy Bledsoe abstained. Motion passed.

ACTION ITEMS:

Adopt the Budget for the 2012-2013 School Year:

Jody Payne made a motion to adopt the budget by fund and function for the 2012-2013 school year. Mark Martinez seconded the motion and it passed unanimously.

Adopt Tax Rate for 2012:

Mark Martinez made a motion to set the 2012 tax rate at \$1.17 per \$100 valuation for maintenance & operations and \$0.08 per \$100 valuation for payment of principal and interest on debt service bonds for a total tax rate of \$1.25. Jody Payne seconded the motion and it passed unanimously.

Consider Approving Fuel Bid for 2012-2013:

A motion was made by Mark Martinez to approve the fuel bid from Triple B Fuel for the 2012-2013 school year. Jody Payne seconded the motion and it passed unanimously.

Consider Approving Fleet Insurance Bid for 2012-2013:

John Casey made a motion to accept the bid from State Farm Insurance in the amount of \$7,633.83 for fleet insurance for the 2012-2013 school year. Jody Payne seconded the motion and it passed unanimously.

Appoint Delegate and Alternate Delegate to the 2012 TASB Delegate Assembly:

John Casey made a motion to appoint Sue Sloan as Delegate and Jody Payne as Alternate Delegate to the 2012 TASB Delegate Assembly in Austin, Texas, on September 29, 2012. Mark Martinez seconded the motion and it passed unanimously.

BOARD REPORT:

Adequate Yearly Progress (AYP) Report:

Lorrie Payne gave a brief overview of the AYP report. Coleman ISD improved in many areas but overall did not meet the federal school accountability requirements for the 2011 – 2012 school year. Mr. Young informed the board that many Texas school districts were filing an appeal to TEA based on the agency's policies and AYP being too restrictive and

excluding an appeal process for very legitimate issues. Also, Coleman ISD may join other ISD's in a suit if appeals are denied.
