Enrollment:	The enrollment is down 64 students from last year as of November 12, 2010. Mr. Young stated that this accounts for approximately \$324,000 in lost revenue. However, he indicated that the budget took into account a decrease in enrollment and is still operating in the black at the present time.
Process of Meeting Compliance In Federal Grant Management:	Mr. Young stated that Coleman I.S.D. has received approximately \$5 million in grants and

that the district is preparing to have those funds audited. District personnel have attended workshops and training to be sure all compliance measures are met.
