2011 Assessment Report:

Enrollment:	Enrollment decline continues to be a concern to the school district and as of December 9, 2011, the district showed a net loss of 24 students from this time last year. As of December 9, 2011, enrollment was 854 total students for the district.
Check Payment List:	The Board reviewed the check payments for the month of December, 2011.
FINANCIAL WORKSHOP:	
2011-2012 Budget:	The Board and Superintendent discussed ways to cut approximately \$400,000 out of next year's budget to address the cuts the state legislature made. Although the district had made substantial cuts for the 2011-2012 budget, deeper cuts will have to be made for the upcoming school year. The Board and Superintendent agreed that they would make every effort to have a balanced budget for the 2012-2013 school year.
